CONTINUING WITH WHARTON'S NEWEST SERIES ON ESG!

Our latest series of mini-sites explores ESG, which stands for **Environmental, Social and Governance**. These materials are drawn from Wharton's 2021 Tarnopol Lecture addressing critical issues facing the business world.

ESG is the lens through which people are evaluating companies' efforts to do more than just make a financial profit Why is this important? ESG is a powerful business trend. Through ESG, companies are exploring and demonstrating their responsibility not just to shareholders, but to a broader group of stakeholders, including the planet, the community and the next generation. As future business leaders and contributors to the workplace and the economy, today's youth must understand how ESG is transforming business, and their role as catalysts for this change.

OUR SECOND ESG TOPIC IS REDEFINING CORPORATE GOVERNANCE

Erika James, Dean of the Wharton School, hosted the 2021 discussion "ESG: Redefining Corporate Governance" in November 2021. Corporate governance describes the rules, practices and processes used to direct and manage a company, which is often overseen by a company's board of directors, an elected group of people who supervise the activities and managerial decisions in an organization. How is governance changing? How can corporate boards become more effective in driving change inside and outside corporations? How can they support ESG-directed decisions?

The activities on this mini-site all connect to the "ESG: Redefining Corporate Governance" discussion and provide opportunities for high school students to *Explore Business* in different ways. They include:

- A link to a published written summary of this discussion.
- Portions of the main video discussion divided into six themed video segments.
- · Guided questions for each video segment in PDF format.
- Links to Wharton Global Youth Video Glossary terms and online business journal articles related to each video segment, included in the guided-question PDFs.
- A PDF Choice Board that allows students to choose different ways to further explore concepts introduced in this ESG Corporate Governance discussion.

High school educators are encouraged to review all the materials related to "ESG: Redefining Corporate Governance" and incorporate individual or collective activities into your classroom discussions and assignments, in person and online. Start with the introduction at the top of this mini-site homepage, which sets up the *ESG Corporate Governance* discussion and provides context about why it is relevant to your students, then dig in. *Explore Business* is meant to be a complement to your curriculum, built with expertise and insights from the Wharton School community. Wharton is a world leader in business education. You can fit all or parts of our ongoing ESG discussions into your daily, weekly or monthly lessons, however it works best.

LEARNING OBJECTIVES

After engaging with the *Explore Business ESG Corporate Governance* discussion, students should be able to:

- Define corporate governance and how it is changing as a result of ESG.
- Understand how corporate boards are responding to the call to address ESG factors for all stakeholders, not just financial shareholders.
- Articulate the strength and ongoing importance of the ESG call to action as corporate boards focus on integrating it into strategy and culture.
- Begin to see how issues like diversity and compensation play out in the corporate environment and impact decision-making.
- Become familiar with key business and finance concepts through the lens of academic research and business experience.
- Think about ways to apply these new ideas and discussions to their own experiences and lives.
